

# 5 Not So Obvious Reasons Why Investors Prefer the Portugal Golden Visa Over Others

[The Portugal Golden Visa program](#) has been attracting investors since its inception. And despite the recent 2022 changes, it continues to see new investors willing to combine the possibility of applying for a residence permit, while also diversifying their portfolio of investments.

Real GDP growth is forecasted to increase by 5.4 percent in 2022 and 1.8 percent in 2023. Public investments, supported by European Union funding, and the return of tourist exports are expected to boost economic activity. However, the ongoing conflict in Ukraine, supply chain disruption, and higher oil and gas prices will dampen business sentiment and consumer spending. Inflation is anticipated to rise to 6.3 percent in 2022 and 4 percent in 2023.

**But investors are still flocking to Portugal even with all those recent factors being priced in. And its golden visa program seems to continue to be the most attractive these days in Europe, with more foreign investors choosing Portugal over other similar programs.**

There are some more obvious reasons, that are generally pointed as the main attractive factors for investors to consider the Golden Visa Portuguese program, specially the following:

- Starting from €250,000, there are **affordable investment options available**. This has been the main factor when

comparing to other golden visas. The Portuguese program has one of the lowest barriers in terms of investment needed.

- **Tax benefits:** visa holder residents don't need to pay additional tax on their earnings made abroad. A great option as it allows investors to directly benefit from Portugal's Non-Habitual Tax Regime or NHR.
- **Access to the Schengen Area** giving permanent free entry and movement throughout 26 nations in the EU & visa-free travel to 183 nations. For non-EU investors, this has served as a first entry to the EU zone and something which has been attracting citizens from all other continents and countries.
- **Short stay requirement:** when compared to other golden visa schemes, you are only obliged to reside in the country some days every year, during your 5 years golden visa timeline.
- **Portuguese citizenship:** even though investors don't have a direct path to citizenship like in Caribbean citizenship by investment programs, once an investor becomes a resident, they can apply for citizenship after 5 years. This is another reason why many people choose the Portugal Golden Visa Program. It gives them the opportunity to become a citizen of Portugal, and therefore gain access to all the rights and privileges associated with it.
