- The Client's Provider Authorization (CPA)

- Software Vendor License

What is the Process for Applying for a Kahnawake Gaming
License?

In Kahnawake, the standards set by the gaming commission for the **gaming license requirements** are very high. First, the company seeking the license needs to establish a corporate presence in some jurisdiction. After that, an application is made to the commission for a gaming license.

Here, all the necessary documents are provided and reviewed by the commission. Due diligence is conducted, and decisions are reached to provide a 6-month preliminary permit. This is more like a probation period, after which the commission conducts a compliance audit and review. If the company fails, the preliminary license is withdrawn. When it passes this stage, a

full Client Provider Authorization is given, valid for five years.

## What Does a Kahnawake Gaming License Cost?

It is not enough to know **how to open a gaming business**; you must also know the cost. The cost of a Kahnawake gaming license is currently around 40,000 USD for the initial license and a subsequent 20,000 USD annual renewal fee. Also, aside from the cost of the license, it is important to note that the annual fee varies based on the license type you have. When all costs are paid, the processing times take between four to six months.
