#### CONSULTATION PROCESS

Forth Ports Limited is delighted to bring forward proposals for Harbour 31, an exciting regeneration of land to the South of Edinburgh Dock which will provide new homes, commercial and retail space, hotel use, flexible work and office space and associated routes, landscaping and amenity space.

The site, situated to the south of Edinburgh Dock, is currently used for industrial port activities. The redevelopment of this area represents an exciting opportunity to create a new neighbourhood within Leith whilst providing high quality architecture and public spaces which will enhance the city's connection to the waterfront.

A Proposal of Application Notice for the proposed development was submitted to City of Edinburgh Council on 26 May 2022 setting out the details of pre-application consultation.

Forth Ports Limited welcomes the views of the public to assist in developing the proposals further. The proposed development forms part of Forth Ports' plans to contribute towards the ongoing regeneration of Edinburgh's Waterfront and presents a unique opportunity for residential led mixed use development at the Port of Leith.

#### TIMESCALES

**Summer 2022** Forth Ports Limited will continue to progress the design of their proposals. This will take into account feedback from community engagement and Pre-application discussions with City of Edinburgh Council and other stakeholders as well as the findings of technical studies.

Late Summer / early Autumn 2022 Forth Ports Limited will host a second community engagement event, the details of which will be confirmed. Details of the event will be placed on the website.

The design of the proposals will continue to be developed following the second consultation.

**Autumn 2022** The proposals will be finalised and it is intended that an application for Planning Permission in Principle will be submitted to City of Edinburgh Council.

#### THE SITE AND ITS HISTORY


Leith Docks have developed considerably over the years. A series of quays bordered the Water of Leith for nearly 500 years. This developed significantly in the 19<sup>th</sup> century with new land created along the north of the Shore, with the enclosed Queen's Dock opening in 1817, Victoria Dock opening in 1852, Albert Dock in 1869, Edinburgh Dock in 1881 and the Imperial Dock in 1904.

The site has historically been used for industry related to the import and exports utilising the Edinburgh Dock.

It was predominantly used for Timber and Coal storage at the tail end of the incoming Leith Railway line.

Recent uses have included scrap metal yards, concrete batch plants and glass recycling depot.












Climate Study: Sun Path And Prevailing Winds





Parcels of Land With Potential For Development






