


## **Project Background**

We are changing streets in Leith with new community spaces and making it safer and more comfortable for anyone walking, wheeling or cycling. Please read on for further information on construction starting and how to provide feedback on our updated designs.

During 2023 we made changes including community inspired artwork, new benches and planting and pavement buildouts to help pedestrians cross the streets. Alongside this we have put in place some trial measures to change how motor traffic moves through the area and reduce non-residential through traffic.







Results of the trial will be reported to the relevant Council committee early in the new year for a decision on whether they should be made permanent. On our website you can read more about these improvements and the results of our monitoring we have done so far.

# Foot of the Walk to Dock Street – construction work starts this autumn

Construction work will start this autumn on the new walking, wheeling and cycling route between Foot of the Walk and Ocean Terminal. The first phase of work will be on Great Junction Street and Henderson Street to Dock Street. Alongside providing safer cycling facilities south towards the city centre, this new route will also:

- provide new signalised pedestrian crossings on Great Junction Street
- improve pavements
- install new soft landscaping areas
- make permanent changes to the temporary arrangement at Sandport Place Bridge
- make Yardheads and Parliament Street accessible for motor vehicles only from Cables Wynd

Our contractor will share more detail about construction arrangements directly with you before and during the work. #### Hawthornvale to Seafield route - share your views
